Microsoft 365 Everywhere engagements are open to US managed customers with at least one of the following licenses:

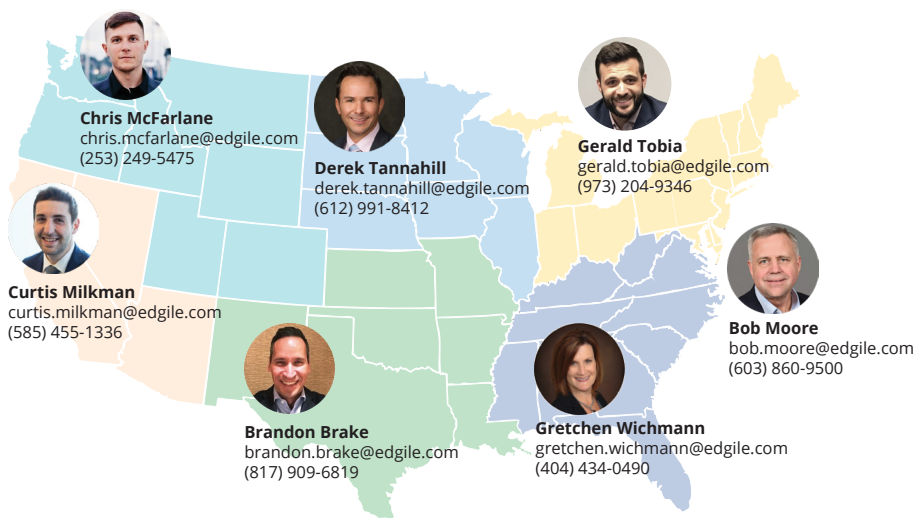
- Office, Windows, or EMS E5/G5
